Description	Neonatal Death. baby was born on the PD of June, 2015 after an emergency caesarean section for failed induction. Maternal PROM for 36 hours prior to delivery. Born initially in good condition with good apgars however at 12 mins of age became pale and floppy which required rescue breaths with a good response. Baby was admitted to the NNU at 4 hours of age with poor respiratory effort and initial saturation were 48% on admission. Baby required respiratory support and antibiotics were commenced for suspected sepsis. CRP was not elevated above 6 on the 22/06/2015 baby's condition deteriorated and baby's skin became extremely mottled. At 03.45hrs baby's condition deteriorated and full resuscitation was required - baby did not recover and died at 04.25hrs on the 22/06/2015
Action taken	All the relevant documentation was completed and the head of urgent care and the clinical risk facilitator was contacted. A review was completed by the Neonatal lead Consultant and the Manager to ascertain if there were any commonalities or poor standards of care. There was none found.
