Introduction

1.1. The Writer

I am Stavros Michael Stivaros. My specialist field is paediatric neuroradiology. I am the lead consultant paediatric neuroradiologist at Royal Manchester Children's Hospital (RMCH) which is one of the largest paediatric teaching hospitals in Europe. I research into paediatric neuro-imaging and am Professor of Paediatric Neuroradiology and Translational Imaging at the University of Manchester. I hold a clinical contract as an Honorary Consultant Paediatric Neuroradiologist at RMCH. My clinical duties include the routine clinical reporting of paediatric brain and spine scans of which I routinely report approximately two and a half thousand per year. As part of my duties I report the majority of the neuroradiological imaging pertaining to suspected non-accidental injury that present to RMCH as well as supra-regional peer review of said imaging due to our role as a tertiary referral centre. I also routinely report brain imaging looking for abnormalities which may relate to birth asphyxia.

I became a fellow of the Royal College of Radiologists in May 2006, and was the Royal College of Radiologists Constance Thornton Fellow 2008 during which time I undertook specialist paediatric neuro-radiology training at Sheffield Children's Hospital. I hold a PhD in advanced neuro-imaging awarded in 2010 from the University of Manchester, obtained during a Medical Research Council Clinical Training Fellowship. I was the 2012-2014 British Society of Neuroradiologists du Boulay Visiting Professor of Neuroradiology. I lecture extensively on paediatric neuro-radiology. I am a former chair and member of the academic sub-committee of the British Society of Neuroradiologists. I am part of the Royal College of Radiologists expert panel for the imaging referral guidelines iRefer and for the National Cancer Research Institute. I sit on the Royal College of Radiologists Professional Development and Learning Committee. My full CV has been made available to the court.
