Dear Claire,

You are right when you say that I have concerns but these concerns are not just in relation to the planned meeting on Monday 18/07/2016. With Lucy Letby and Sister Yvonne Griffiths. I understand from our member, that there have been unacceptable high mortality rate on the Neonatal Unit at COCH. It has been alleged that our member has been involved with more of the deceased patients than any other member of staff. According to our member she is going to be informed at the meeting on Monday, that she will have to work under direct supervision and an action plan will have to be followed.

Also our member, was called into a meeting on the 14/07/2016 with her manager and Sian Edwards, were she was told that she will have to redo all of her clinical skills and competencies, as per what would be expected of a newly qualified nurse.

My concerns are more to do with processes, what process has been followed in this instance and how has the Organisation come to the conclusion it has. I would like to see evidence of an investigation into these allegations and the subsequent outcome. Who was the

investigation officer. What evidence is there to suggest that our member may be linked to these unexplained mortality rates. Given the gravitas of what is being alleged by the organisation, I feel that it is imperative that I attend any form of meeting that our member is requested to attend, be it informal or formal.

I believe our member has a right to be fully consulted and a full and frank explanation is given by the organisation into my concerns. If you wish to discuss this any further then please do not hesitate to contact me on 0 I&S I will be accompanying our member to the meeting on Monday as I believe our member is being treated unfairly by the organisation.
