Dear Ian,

George Kokai, Rajeev Shukla and I have discussed the clinical scenarios and macroscopic and microscopic PM findings and conclusions for these four cases. I attach a summary of our conclusions for each case, which they have seen and agree with. As the original post mortem reports include a full clinicopathological correlation, with in depth discussion, I have not reproduced those here.

Please note that this is not a full and formal medicolegal review; this would involve a second reporting and take about 4 hours of work per case, with a subsequent lengthy report. If you require an analysis of this depth, it is probably best performed independently by someone from another centre. However, the histology is not available on the first two cases, as per the families' requests for
