Also Debbie, presumably you will need to let Ruth Milward know and if Ruth or another quality improvement representative would like to attend, that would obviously be fine. I will ask if Jo Davies wants any obstetric representation.

The meeting date is also unlikely to be before Debbie leaves us which is a shame but maybe your successor can be fully updated.

I'm away for most of next week but will try to pick up my emails most days if anyone has anything to add.
