I am emailing yet again on behalf of our member Miss L Letby. It has come to my attention today that my member met with some colleagues yesterday as she is now allowed to do.

Yesterday some of her colleagues informed her that a Consultant ( SB) is going around the NNU and informing staff that he has seen the external report and I quote " appears to be bragging about it" stating " the report has cleared all the medical team as expected" and he also informed the staff that he had been given the funding for a new Consultant post because of it.

Staff then asked the Consultant when do they get to see the report and he stated he was surprised the staff hadn't"

On behalf of my member we would like to know why this is happening as we were given assurances not two weeks ago that a confidential meeting would take place with the Medical Director and key people regarding the draft report and that it would be kept confidential until the report finalised and that nothing would be discussed as yet.

My member is again upset and distressed over this as my member has done everything the trust has asked of her and yet still appears to be being penalised for this and is still none the wiser what any report says.

I find this completely unacceptable when we have been given reassurance after reassurance over the reports etc and am disappointed that we have had to email again.

If this continues we will have no choice but to seek further advice
