#### Hiya

As you know, the COCH commissioned the RCPCH to undertake a review of the neonatal unit following a period of increased mortality. The report highlighted surprise/concern that the CDOP had not spotted this.

I have spoken with Hayley Frame (Independent Chair of the Pan Cheshire CDOP) this morning to discuss the next steps (see the email below). We were intending to propose that the CDOP undertakes a review of the case notes, as highlighted in the RCPCH report but Gill Frame (Chair of LSCB – and no relation to Hayley) has been told by COCH that the review has already been undertaken.

We are therefore going to recommend that CDOP reviews this to provide external scrutiny and I think there is a case for the COCH to bring this to People's Scrutiny as well. (The LSCB will be considering the RCPCH report in June).

Donald Read provides the Public Health input into the CDOP currently. (We rotate support every two years) so there will be a consistent CWAC link while this issue is explored.
