I qualified as a Childrens Nurse in September 2015 at Chester University following a completion of the Degree of Bachelor of Nursing with Honours (Children's). However, I was employed by the Countess of Chester Hospital as a Band 4 Bank Nursery Nurse due to studying for my Postgrad in Specialist Public Health Nurse -Health Visiting in September 2015-2016. I worked nightshifts as and when I was available. I'm currently employed as a Health Visitor in Nottingham (Band 6) since 2017.

2. What were your duties and responsibilities (including any management responsibilities) as a nurse on the neonatal unit (the "NNU") at the hospital in 2015 and 2016?

I worked night shifts and from what I remember my duties as a Band 4 were the following:

- Observations on babies including temperature, heart rate and respirations
- Feeding
- Nappy changing
- Record keeping
- Parental interactions

I did not have any management responsibilities.

3. How would you describe the quality of the management, supervision and/or support of nurses on the NNU between June 2015 and June 2016?

I did not have much interactions with management as I only worked a couple of nightshifts. As a Band 4 I worked under the supervision of staff nurses and at the time I did not have any issues with the supervision given by the nurses.

4. How would you describe the relationships between: (i) clinicians and managers; (ii) nurses, midwives and managers; and (iii) between medical professionals (doctors, nurses, midwives and others) at the hospital between June 2015 and June 2016?

I am unable to comment on the relationships mentioned above as I only worked a couple of nightshifts and did not have much interactions with the above.

Having CCTV in the rooms where babies are is beneficial and allows for remote monitoring. It is also a good deterrent.
