I am aware that the notes are now with yourself and Dr Brearey for the purpose of a neonatal review and wonder if you could discuss this case with Ruth prior to the review taking place so that we can agree on the format of the review. As the Coroner has asked us to consider undertaking a SUI investigation would it be beneficial to undertake the review in this format?
