Just to check – I don't think this is the "external" review that Ian referred to in the meeting he had with Lesley, Andrew and myself?

I know cannot recall whether we have seen this report before, but I don't recollect reading this document.

I was hoping to see the individual case note review of each death recommended in the report

and mentioned in the February 2017 external review action plan.

The report also makes reference to an appendix 4 (para 3.7) but it is not attached. Has anyone seen it?

Para 4.4.4 – it is not a recommendation but do we have a view on whether an external adviser or risk midwife should attend the M+M meetings and the review action plan is not explicit about responsibility for auctioning findings and implementation of lessons learnt.

The comments at 4.6.2 are significant, especially the last one.
