Thanks Steve. I have gone through it trying to be a 'lay' person i.e. police or trust board member. I have added a glossary of terms & including a survival chart (to avoid the 'all neonates likely to die' mentality). I think we need to be more explicit if possible and have 'suspicion of criminal activity' comment next to any of those where people can recollect abnormal behaviour e.g. Ravi's case with the dislodged tube during the other nurses short period of time off the unit. If I were police reading this...I would want to know which cases to pick up first to prove/disprove criminal activity and we can provide that guidance with a few pertinent reflections. Clearly we have to be careful in putting it in writing but as Simon said we have to show them evidence (or potential evidence) of criminal activity or we will continue to be drowned out by endless trust level reviews. I agree with John's comments - our expert opinion is evidence in itself so we should be stating if death expected or not.

As you say, it's not clear for whom we are preparing this report but the potential readership includes the Police (or at least the police officer who sits on CDOP). Therefore, on the assumption that some of those reading this report may have little medical knowledge, I've tried to explain medical terms (even simple ones like apnoea and bradycardia), and also to ensure that abbreviations are given in full the first time these appear - or, rather, I've done this for the deaths but not for the very brief summaries of the non-fatal collapses listed at the end. It's good to have the non-fatal collapses recorded in the report to indicate that it's not just deaths that concern us, but you are right to have concentrated on the deaths since it's these - we have been advised - that are most likely to interest the Police initially (if and when they get involved, then presumably the non-fatal collapses will also be considered at some stage).

All other suggested changes are explained by comment boxes.
