You will recall that I have advised you that the inquest into the death of baby [Child A] is to be held at Warrington on Monday 10th October 2016 at 9.30am.

The inquest is set for a half day before H.M. Coroner for Cheshire, Mr Rheinberg and the family are legally represented.

6 of our clinicians are giving evidence at the inquest and I have provided support and held case conferences with the clinicians and all the necessary preparations have been completed.

The Coroner is aware of the review undertaken by RCPCH and the necessary disclosures have been made.
