Thirlwall Inquiry

ALL OF THE NEONATAL DEATHS LINKED TO THE COUNTESS OF CHESTER HOSPITAL IN 2015 AND 2016

Overview

- 1. This document sets out an index to all of the neonatal deaths linked to the Countess of Chester Hospital in 2015 and 2016. It is understood that there were 10 neonatal deaths in 2015 and 8 neonatal deaths in 2016.
- 2. Of the 18 deaths listed in this document:
 - a. 13 deaths occurred on the Neonatal Unit at the Countess of Chester Hospital and have been the subject of a police investigation.
 - b. 4 deaths occurred on other Hospital Neonatal Units post transfer and have been the subject of a police investigation, this includes Baby K.
 - c. 1 death occurred on the Central Labour Suite at the Countess of Chester Hospital (a separate unit from the nurseries where the unexpected deaths of the indictment babies occurred). This baby was not the subject of a police investigation.
- 3. Two of the deaths that occurred on a Neonatal Unit (either at the Countess of Chester Hospital or other Hospital Neonatal Units post transfer) remain the subject of ongoing police investigation.
- 4. The cause of death recorded at post-mortem or the registered cause of death (for babies who did not have a post-mortem) is set out in this document. For indictment babies, the mode of attack/cause of death determined at the criminal trials is included. For non-indictment babies, information about the date of death and the conclusion at post-mortem or the registered cause of death is minimised to '1a.' to preserve their anonymity. Please note, '1a.' is the disease or condition recorded as immediately causing death.
- 5. The document also identifies which babies were included in key internal and external reviews. Core Participants have access to the findings of these reviews on Relativity.

Sister Powell's first review, dated 23.10.2015, does not include the non-indictment babies that died in December 2015 and January 2016. All the non-indictment babies in the Thematic Review are captured in her reviews dated 19.01.2016 and 02.03.2016.

Baby E did not have a post-mortem. 1a. Necrotising Enterocolitis and 1b. Prematurity was the agreed cause of death between Dr ZA and the Coroner.
